Business and Professional Operators License

Due February 15. Forms may be acquired from the Buchanan Town Hall at 19753 Main Street (540) 254-1212.

License – \$25.00 minimum, based on gross receipts.

License obtained from the Buchanan Town Hall, or, downloaded using the links below. Zoning approval is required first, as well as a Sign Permit from Buchanan Town Hall before placing any signs.

Water, Sewer & Garbage Fees

Customer are billed monthly and bills are due upon receipt each month – Please set up your account at the Buchanan Town Hall at 19753 Main Street (540) 254-1212.

Renter’s Water Deposit – \$200.00
Property Owner Deposit – \$0.00

Monthly Charges:

Water, Sewer and Garbage customers are billed monthly for services. Residential Customers are charged \$48.25 for the first 4,000 gallons of water, \$38.25 for sewer, and \$17.00 for garbage pickup. Commercial customers are charged \$50.25 for the first 4,000 gallons of water, \$38.25 for sewer and \$23.00 for garbage. Water and sewer usage over 4,000 gallons per month are charged additional fees.

Water and sewer usage over 4,000 gallons per month are charged additional fees. Out of Town water rates are 1.5 times the base in-Town rate for residential and commercial. Late fee for water, sewer and garbage is \$20.00. If your water is cut off due to lack of payment there will be a \$60.00 Reconnection Fee.

Dumpsters to be located and screened per Town Zoning Ordinance.
